

ENVIRONMENTAL ATTRIBUTES AND CERTIFICATIONS

TERMS OF USE ON PRINTED DOCUMENTS

THE FOLLOWING GUIDELINES MUST BE RESPECTED IN ORDER TO USE THE LOGOS ON YOUR PRINTED DOCUMENTS.

THE LOGOS:

- ✓ may only be used on Rolland certified papers
- ✓ must include a statement linking them to the paper to confirm the purpose of the certification (see examples below)
- ✓ must not be altered in any way and must remain in their original proportions
- ✓ must be of a sufficient size to make their text legible

EXAMPLE 1: ROLLAND 100% RECYCLED PAPER

SUGGESTED STATEMENT:

Printed on Rolland Enviro (*specify product name and basis weight, e.g. Rolland Enviro Print, 80 lb, Text*). This paper contains 100% post-consumer fiber, is manufactured using renewable energy - Biogas and processed chlorine free. It is FSC® and Ancient Forest Friendly™ certified. Rolland's FSC® certification with NEPCo is recognized by the Rainforest Alliance.

EXAMPLE 2: ROLLAND 30% RECYCLED PAPER

SUGGESTED STATEMENT:

Printed on Rolland (*specify product name and basis weight, e.g. Rolland Opaque 80 lb, Text*). This paper contains 30% post-consumer fiber, is manufactured using renewable energy - Biogas and is elemental chlorine free. It is FSC® certified. Rolland's FSC® certification with NEPCo is recognized by the Rainforest Alliance.

Thus, only the printer's logo may appear on a printed document. Only FSC-certified printers may use the FSC label.

These logos may only be used by the manufacturer, but the Ancient Forest Friendly™ certification may be included in a statement such as the one suggested above according to the product. This does not apply to the Rainforest Alliance certification.
